

## **Magellan Flagship Fund Limited ('MFF') Weekly Net Tangible Assets ('NTA')**

MFF advises that its approximate weekly NTA per share as at Friday, 19 September 2014 was \$1.617 pre-tax (cum 1 cent per share, unfranked dividend)<sup>2</sup>, (30 June 2014 \$1.427), and \$1.437 post-tax<sup>1</sup>.

Note that no adjustments are made for future exercises of the MFF 2017 options (exercise price \$1.05 per option). The approximate pre-tax NTA would have been reduced by approximately 13.0 cents per share if all of the MFF 2017 options had been exercised on Friday, 19 September 2014.
