

**Magellan Flagship Fund Limited ('MFF')
Weekly Net Tangible Assets ('NTA')**

MFF advises that its approximate weekly NTA per share as at Friday, 12 February 2016 was \$1.869 pre-tax, (cum 1 cent per share, fully franked dividend)², (30 June 2015 \$1.998), and \$1.656 post-tax¹.

Note that no adjustments are made for future exercises of the MFF 2017 options (exercise price \$0.9964 per option). The approximate pre-tax NTA would have been reduced by approximately 12.5 cents per share if all of the MFF 2017 options had been exercised on Friday, 12 February 2016.
